- Poisons (cyanide)
- Oxidizers (hypochlorite pool chemicals)
- Flammable Solids (flares)
- Peroxides (hardeners for fiberglass)

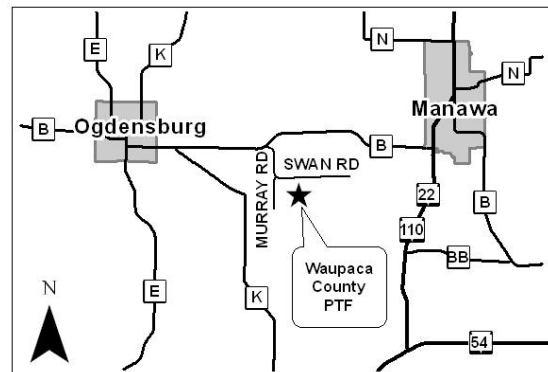

**NO asbestos-containing material  
 accepted at Facility.**

2. Clear Glass Bottles  
 (food & beverage ONLY)



**NO** window glass, light bulbs,  
 mirrors, dishware, ceramics

3. Plastic Bottles & Containers

- Food/Drink/Detergent, etc.
- Dairy/Produce/Bakery/Deli



Aluminum Cans

Steel/Tin/Bi-metal Cans



**NO** 5 gal. pails, plastic bags, motor oil  
 bottles, plant pots, laundry baskets

4. Newspaper, Magazines, Mixed Paper,

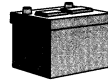

Cost: \$2.50 per bag  
 Solidifies approx. 2/3 gallon of latex  
 paint in 15 min. Solidified paint can be  
 disposed of in trash.  
 (for use with water-based latex paint only)

 additional \$20 FEE
- **Must be scaled in 15 minutes  
 prior to closing**
- **No Soliciting** allowed on premises
- All material left at the PTF becomes  
 the property of Waupaca County
- Activity on the premises is recorded
- Prices subject to change
